

RODO Intern clause

 - other entities participating in the project.
- 6) Access to your data is provided to the employees authorized by the data administrator.
- 7) Providing your personal data by yourself is voluntary, in the event of failure to do so, you will not be able to take part in the project.
- 8) You have the right to access your data and the right to rectify, delete and limit processing, as well as the right to object to the processing.
- 9) You have the right at any time to withdraw your consent to the processing of personal data by sending a message to the following address: risfellowships@wz.uw.edu.pl.
- 10) Your personal data will be stored until your consent to the processing of data is revoked by you.
