GDPR Intern clause – EIT Food RIS Fellowships Action Line

- 10) Your personal data will be stored until your consent to the processing of data is revoked by you.
- 11) Your personal data has been collected through the application form shared on the project website: www.eitfoodrisfellowships.eu and available on EIT Food application platform: https://apply.eitfood.eu/.
- 12) You have the right to lodge a complaint to the General Inspector for Personal Data Protection if you decide that the processing of your personal data violates the regulations of the General Regulation.
- 13) Unless you revoke your consent, your personal data will be stored for the period of 5 years.
